

Presenters



Ann Smith is the program manager for the Self Advocacy Goal Subcommittee for the Florida Developmental Disabilities Council and is responsible for program management of the self-advocacy leadership initiatives. Ms. Smith has four adult children including a son who experiences autism and Tourette Syndrome. She has worked in the field of developmental disabilities since 1991.



Barbara Palmer was appointed director of the Agency for Persons with Disabilities by Governor Scott in August 2012. Before coming to APD, Director Palmer was with the Department of Children and Families, served more than 15 years as president and CEO of Palmer, Musick & Associates, and was associate vice president for governmental relations at Florida State University. Director Palmer holds the distinction of being FSU's first women's athletic director.



Troy Munn has a 26-year career in professional fundraising. He has experience in annual giving, major gifts, and planned gifts in private and public higher education and health-care environments. Mr. Munn served at the University of Florida College of Medicine during the Florida Tomorrow Campaign, the state's largest-ever fundraising campaign effort that raised \$1.7 billion.



Margaret J. Hooper has been the public policy coordinator of the Florida Developmental Disabilities Council since 2005. A registered lobbyist, her primary responsibility is the planning, development, and coordination of the Council's public policy and advocacy activities. Ms. Hooper has been a court counselor for the Office of the Public Guardian; a project director of the Louis de la Parte Florida Mental Health Institute (FMHI); and served as executive director of the Alzheimer's Project of Tallahassee.



Erin Hyne is a self-advocate and active member of FL SAND's Stand Up for Independence (SUFI) group from Florida's Treasure Coast. She participates in Special Olympics of Martin County and is a member of their Leadership Academy. Ms. Hyne is an avid Miami Dolphins fan and loves to interact with the community. She was successful in forging a partnership with Home Depot in support of the Treasure Coast Down Syndrome Awareness Group.



Eddie Hall is a self-advocate from Lakeland, FL SAND vice president, and an FDDC member. He has an Associate's Degree in Computer Engineering and was the first person in a wheel-chair to work for Publix where he went from working in the dispatch department to serving as the systems administrator for the Transportation Routing System. Mr. Hall has served on a number of boards and committees, including the Polk County and Florida PTAs, the Lakeland Housing Authority, and Transportation Planning Organization.



Amanda Baker is a self-advocate from Panama City, is vice-chair of the FDDC, and parliamentarian of FL SAND. She is a graduate of Partners in Policymaking and recipient of the 2015 Idelio Award. She started the Elephant Herds self-advocacy group in Panama City. Ms. Baker has significant experience in public policy and advocacy and is employed as a Vocational Rehab technician.



Paula Roberts is the external affairs coordinator for Disability Rights Florida. Her role is to educate individuals with disabilities, their caregivers, and state agency representatives on how to access services from local, state, and federal agencies. Her trainings include "How to Become an Efficient Self-Advocate," information on transition services, systemic issues, and obtaining information and resources from Disability Rights Florida.

Presenters



Arizona Jenkins is a self-advocate and the founder and president of the New Horizons Support Group for People with Disabilities in Tampa. Mr. Jenkins mentors persons with disabilities in self-advocacy and school children in Tampa. He has served on several municipal boards advocating for persons with disabilities and is a seasoned recruiter of resources and allies for New Horizons in his community.



Bernadette Moran has been an active advocate for individuals with disabilities for 29 years, beginning with the birth of her daughter who has Down syndrome. Ms. Moran has been an active member of the Down Syndrome Association of Jacksonville for many years and is a board member and past president of The Arc Jacksonville. She has been active in politics as it impacts the disability community and is currently an FDDC council member where she chairs the Housing and Transportation Task Force.



Whitney Harris serves as special projects administrator and assistant to the executive vice president for the Florida Chamber Foundation in Tallahassee. Ms. Harris leads the Foundation's Internship Program to place qualified Floridians with disabilities into temporary employment and coordinates its Florida 2030 Town Hall Meetings in all 67 counties. As a self-advocate, Ms. Harris has been heavily involved in disability advocacy organizations that serve youth.



Michael Daniels is the executive director of the Florida Alliance of Assistive Services and Technology (FAAST). Mr. Daniels has been working in the assistive technology field for over 20 years with a focus on computer access and seating and mobility. He served as program director at FAAST for four years and was instrumental in the development of the statewide device loan program and the addition of two Regional Demonstration Centers.



Elizabeth Perkins, Ph.D., is the associate director of the Florida Center for Inclusive Communities at the University of South Florida. She teaches future health professionals how to better care for people with different types of disabilities and develops health promotion and advocacy resources. Dr. Perkins conducts research in the areas of aging and caregiving, is the vice president of the American Association on Intellectual and Developmental Disabilities, and serves on the Florida Developmental Disabilities Council.



Tina St.Clair is CEO of Organizational Management Solutions, a consulting firm in Jacksonville, and training and technical assistance provider to FL SAND. Ms. St.Clair previously worked for Lutheran Services Florida and the Department of Children and Families as an administrator for the public mental health and substance abuse system of care. She is a Licensed Clinical Social Worker, Master's Level Certified Addictions Professional, and Substance Abuse Professional.



Kelli Munn partners with Tina St.Clair at Organizational Management Solutions to provide training and technical assistance to FL SAND as the Project Manager. She is also the owner of Kelli Munn PRM, a public relations and marketing consulting company in Jacksonville and has more than 25 years experience in the nonprofit communication field. Ms. Munn has also taught communication at the University of Florida, Valdosta State University, Auburn University, and East Carolina University.



Abilities Venti is FL SAND's self-advocacy group in Pembroke Pines. It is a not-for-profit organization created by and for adults with disabilities. 
